Limited Warranty & Terms and Conditions of Sale

If there are any health concerns call Paradise Pet Centre immediately. 780-459-6896.

Paradise Pet Centre Ltd. extends the following limited warranty only to the Buyer or his/her immediate family. In signing this guarantee, the buyer recognizes their responsibility to maintain the health and well-being of this animal. During your pet's stay at Paradise Pet Centre Ltd, (from here on referred to as PPCL) we have maintained, cared for and provided it with all necessary Veterinary care at our company's expense. PPCL would never knowingly sell a sick animal and the Buyer agrees that PPCL could not have been aware of any illness or defect at the time of sale. Once you take your new pet home, this responsibility belongs to you. You must provide it with the proper care and any Veterinary attention it may require is the Buyer's expense.

This limited warranty covers this pet only. PPCL is not responsible for any associated charges, such as veterinary fees. All of the limited warranties offered by Paradise Pet Centre Ltd. are subjected to the terms and conditions outlined below.

LIMITED FIVE DAY WARRANTY ON HEALTH

If your reptile, in the opinion of PPCL, has any physical problems which present a health risk, PPCL will provide you with a replacement reptile of equal value. To make a claim for a replacement reptile, bring your reptile back to PPCL within 5 days from the time of purchase accompanied by the sales contract and receipt. In some cases PPCL may take the reptile and enclosure for observation depending on the symptoms being displayed.

Please note: since reptiles are temperature and environment sensitive, proof that the reptile has been placed in appropriate living conditions must be met. Proof of purchase of the products bought to create the reptiles' environment may be used for confirmation of adequate living conditions.

This limited warranty covers your reptile only. PPCL is not responsible for any associated charges, such as veterinary fees. All of the limited warranties offered by PPCL are subject to the terms and conditions outlined below.

Paradise Pet Centre Ltd. will not offer an exchange or replacement pet if the above terms are not met. There will be no exchanges or refunds due to: allergies or allergic reactions to your new pet by owner or family members, any injury induced after the sale (including broken bones), a dislike for the pet, or any problems with a landlord.

GENERAL TERMS & CONDITIONS

- If the Buyer qualifies for a replacement pet, you can choose a new reptile with a retail price equal to or less to that of the purchase price of the pet. You can take up to 60 days to make a decision.
- If the Buyer chooses a replacement which has a retail price greater than this pet the difference must be paid by the Buyer.
- If Paradise Pet Centre Ltd. is not able, within 60 days, to offer the Buyer a replacement pet of similar species and retail price as this pet, you will be entitled to a full refund of this pet's purchase price.
*Note: this is the *only* circumstance in which you may claim a refund under these limited warranties; otherwise, there are no refunds or exchanges on live animals.
- The limited warranties apply to live animals only and not to merchandise.
- If this pet is found to have a health problem at its initial veterinarian visit and Buyer opts to treat this pet WITHOUT PRIOR APPROVAL of PPCL, under no circumstances will PPCL be liable for any outcome or costs associated with veterinary treatment. PPCL will assume responsibility ONLY for cost of treatment through a Veterinarian of OUR CHOICE.
- If the Buyer wishes to make a claim, bring this warranty with you. If you don't have this warranty, you are still entitled to all the rights under it. However, you must have proof of purchase that shows YOU purchased your pet from Paradise Pet Centre Ltd. You, and your Veterinarian, may rely on this information.

This written agreement is the entire agreement between the Buyer and PPCL of the pet purchased today. I will not rely upon any oral statements contrary to this written agreement. I, the Buyer, have read, understood, and accept all terms of this contract.
